CLASSIC HITS 104.1'S "AT WORK VIP" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WHTT-FM ("Station"), owned and operated by Cumulus Radio LLC located at, 50 James E Casey Drive, Buffalo, NY 14206, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

All entries must be received by 11:59 pm ET on September 27th, 2018 to be eligible for the Grand Prize drawing. Limit one (1) entry per person per day per email address. Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the participant. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Station reserves the right to contact

- 4. **Winner Selection.** On or about 9:00 am ET on weekdays during the contest period, Station will select one (1) entry for the Grand Prize in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.
